COMMENT

Land use policies set out a guide for applicants and establishes a Council or collective of Councils position on land use and developments.

A policy of interest regarding tree farm applications in a rural local government is the Shire of Perenjori's <u>Local Planning Policy No 1 – Tree Farms</u>. This is raised with members due to tree farm establishments in the Shires of Morawa, Perenjori and Dalwallinu and more recently Woodside's purchase of farming properties in Mt Marshall and Westonia, so too other investors purchasing farming properties in Koorda with the intent to plant to trees.

It would be beneficial for the NEWROC to consider a policy and position either individually or collectively. For any collective work, this could be carried out internally by the EO and support the Economic Development Strategy.

Discussion at the Executive Meeting:

- Members do not currently have a land use policy for tree farms or renewables
- Shire of Mt Marshall is discussing land use with DPIRD
- Separate issues: investment framework v land use policy. Separate agenda items for Council

OFFICER RECOMMENDATION

NEWROC Executive develop a position or guiding principles on new tree farms in the district, for consideration by members.

RESOLUTION

NEWROC Executive develop guiding principles on new tree farms in the district, for consideration by members.

Discussion:

- The Shire of Nungarin has been approached regarding a future tree farm. It currently has no Town Planning Scheme.
- The Shire of Mt Marshall has requested information from DPIRD regarding productive and non productive agricultural land, the impact of tree farms on this.
- There is a need to differentiate between tree farming and carbon offset projects.



- Considerations that any application for a tree farm must have an economic impact statement attached.
- ACTION: NEWROC EO to ask how the Shire of Perenjori wrote their tree farm policy.

NEWROC EO presented to the Committee conducting the Inquiry into Export Control Amendment (Ending Live Sheep Exports by Sea) Bill 2024 at Muresk on Friday 14 June. Other panelists included: Shire President and CEO of the Shire of Katanning; Shire Presidents of Wagin, Tambellup and Northam.

NEWROC also submitted a <u>written statement</u> to the Committee. Committee will provide a report to Parliament within the week.

At the last NEWROC Council meeting (May) the following resolution was passed:

RESOLUTION

NEWROC receives the information.

NEWROC writes to Minister Watt after input from NEWROC Executive.

NEWROC Executive reviews the transition package announced and implications for the district's economy and communities

Moved Cr Sachse Seconded Cr Trepp CARRIED 6/0

The Transition Package has been announced, so too a timeline (not timeframe). Transition package will include: \$107 million over 5 years available from 2024-25 to assist those impacted, specifically:

- \$64.6 million to support sheep producers and the supply chain, particularly in WA
- \$27 million to enhance demand within Australia and internationally for sheep products
- \$2.6 million to continue improving sheep welfare standards
- \$1.7 million to appoint a Transition Advocate
- \$11.1 million for implementation and engagement



The Transition Package is focused on \$64.6m towards consultants and advisors to support producers plan their way out of the industry. It will also be allocated towards Rural Financial Counsellors. There is limited funding in the package for local governments to access to reverse the economic decline NEWROC is predicting (as per our economic impact assessment).

Between the Executive Meeting at this Council meeting, the legislation was passed.

At the Executive Meeting, the following resolution and action was passed.

RESOLUTION

Investigation into the transition package await further news of the Bill's progression (whether it passes the Senate).

NEWROC Executive will not prepare a letter to the Minister until an outcome of the Bill is known (Council resolution at the last meeting).

OFFICER RECOMMENDATION

The NEWROC await the announcement of the transition package details prior to responding to the Minister for Agriculture (State and Federal).

RESOLUTION

NEWROC retains its position on opposing the Live Sheep by Sea Trade policy and supports the leaders of our agricultural industry in advocating against it.

The NEWROC write to the Federal and State Government requesting \$128m over 10yrs to support the sheep industry in the NEWROC and \$35m to support the communities in the NEWROC, as per the Economic Impact Report on the Live Sheep by Sea Trade Policy commissioned by the group in November 2023.

COMMENT

Following on from the Nungarin workshop on helping private landowners prepare for renewable energy developments in 2023, a potential next step is to establish a NEWROC framework for renewables in the district. This should also flow onto ensuring NEWROC communities receive maximum benefit from investments in the area, that go beyond an annual community grant.

A group of Shires in WA (West Arthur, Dandaragan, Narrogin and Moora) are investigating and preparing policies to safeguard food production and their communities due to increasing interest in using agricultural land to build renewable energy assets or for carbon offsets.

Renewable projects 'coming in large and fast' but local governments worry about legacy, food security - ABC News

An example framework for Local Governments (and their communities) preparing for renewable energy development is in the Shire of Hay (NSW) (attached). Working with their community they have established a set of principles that seek to position their community to aspire for maximum benefit from coming investments.

It would be beneficial for the NEWROC to consider a similar frameworks either individually or collectively. For any collective work, this could be carried out internally by the EO and support the Economic Development Strategy.

At the NEWROC Executive Meeting, the EO was requested to engage with DPIRD regarding land classification (productive / non productive), which will be followed up.

ACTION

NEWROC EO engage with the Shire of Merredin regarding community investment outcomes as a result of the renewable energy developments in their town.

Discussion:

- At the ALGA Conference there was discussion regarding the loss of land when transmission lines are developed (setbacks on towers).
- Guidelines on the development what you get out of it what you get left with?
- Discuss the impact of mining as well (Yilgarn, Westonia).

10.3 Wheatbelt Drought Resilience Plan

The Regional Drought Resilience Planning Program is one of eight foundational programs under the Australian government's \$5 billion Future Drought Fund. Following the successful delivery of the pilot program in 2021-2022 in which Regional Drought Resilience Plans (RDRPs) were developed across Southern Wheatbelt, Inland Great Southern and the Northern Agricultural Region, the WA and Australian government are co-investing to extend the program to the end of June 2025.

The Wheatbelt Development Commission (WDC) is leading the development of a Wheatbelt wide RDRP, building on the learning from the Southern Wheatbelt RDRP Pilot.

The Wheatbelt RDRP will be developed in collaboration with regional stakeholders and identify actions to build regional resilience to future droughts, with a focus on agriculture, allied industries and agriculturally dependent communities. RDRPs will be developed through a triple-bottom-line, collaborative, and evidence-based approach.

A sub committee will support the development of the Wheatbelt RDRP by the Commission. Cr Sachse and the NEWROC EO have been asked to participate in this sub committee.
